Dear Friend of KidsPeace, •

I have a confession: I REALLY don't like to wear a mask. But I always have worn my mask when out during the pandemic, because my inconvenience is insignificant in the face of the challenges that COVID-19 poses to our society.

Here at KidsPeace, the extraordinary year of 2020 certainly was one of enormous challenges – including temporary program closures, staff shortages and unanticipated infection control-related facility costs, along with the human cost of the coronavirus pandemic among clients and staff. But I'm proud to say our people have met those challenges with courage, creativity and compassion, as you can see in this Outcomes and Annual Report.

As I consider all we faced in this past year, I'm struck by how beneficial relationships are to us as we work to fulfill our mission – and how important they were in dealing with the pandemic's devastating impact:

- Managed care organizations and other payors stepped up in innovative ways to help us meet our COVID-related financial challenges, while state and federal representatives worked to secure pandemic relief funding so that we could avoid massive program halts and staff layoffs.
- The generosity of our philanthropic supporters allowed us to continue efforts like walk-in mental health assessments to those facing crisis an offering that not only addressed the clients' needs but helped relieve the burden on hospital emergency departments during the pandemic. Donations also helped fuel revitalization of our TeenCentral.com service just as school closings and societal shutdowns made its offering of therapeutic information and encouragement to young people absolutely essential.
- News media shined light on the pandemic's effect on mental health, and KidsPeace's role in promoting mental wellness from identifying our staff as true "Heroes" in the crisis to publicizing our Mental Health Protective Equipment (MPE) initiative ... even to helping us teach folks how to give a socially distant "Virtual Hug."
- And of course KidsPeace associates in direct care and support roles alike –
 demonstrated their magnificent commitment to those we serve by ensuring our programs
 stayed open and continued to function efficiently and safely for the people that rely on
 them.

In a real way, relationships are what face masks have been all about; as the experts say, "My mask protects you; your mask protects me." KidsPeace is able to help thousands of individuals each year because of the relationships forged with its clients, associates, partners and supporters, and as a result our society benefits as a whole.

Like all of you, I look forward to the day when wearing a mask is just a memory – but all of us at KidsPeace will remember how we were able to harness the power of relationships to meet the challenges and fulfill our mission this past year, and to position ourselves for greater success in the future.




Demographics


Reach of Programming


Education

Schools all across the nation faced enormous challenges in 2020 as a result of the COVID-19 pandemic. The shifting from virtual to hybrid to classroom instruction made it difficult for teachers and students -- and their schools -- to achieve their usual benchmarks in basic skills. Nevertheless, KidsPeace youth continued to receive quality education throughout the pandemic, and maintained or advanced their standing in both math and reading scores.

PA Education

In 2020, our goal was to maintain skill levels identified prior to the COVID-19 shutdown of schools. 60% of our student population experienced gains in their academic performance in math and 58% of students showed academic improvement in their reading scores during their residential placement with KidsPeace as shown in the graphs below.

The KidsPeace Education Department also followed up with former students' current school districts to ascertain if regression of skills were reported. To date, of the 65 students on which we received information, ALL of them maintained their skill levels since leaving KidsPeace.



Maine Residential



Locations: Maine

Clients served: 44 in 2020

Services: KidsPeace New England's Residential Program at the Graham Lake Campus in Ellsworth, Maine, is a 44-bed facility providing therapeutic residential treatment, with an emphasis on serving clients with Autism Spectrum Disorders. The program features high quality educational and recreational therapies for youth ranging in age from 3 to 20 years old, and also offers day treatment services.









Locations: Bowdon, GA **Clients serve**d: 153 in 2020


Services: Residential care and treatment services for Georgia youth. The 80-bed facility is designated as a Maximum Watchful Oversight Program, with four 20-bed living units. Three of the units serve 20 girls and 40 boys with a range of mental health, substance abuse and behavioral issues; the fourth unit is a separate 20-bed unit for male youth with sexual issues. An on-site school, recreational facilities, and a wellness and behavioral-health

center serve the needs of the youth in the program. The campus also offers outpatient walk-in counseling and mental health treatment programs to the community.

Brief Psychiatric Rating Scale for Children (BPRS-C)







In 2020 KidsPeace launched a new residential treatment program called Explorer PRTF. Explorer addresses the needs of teens whose behavioral challenges,


tied to significant traumatic events in their lives, are more severe than those normally addressed in traditional psychiatric residential treatment programming.




Brief Psychiatric Rating Scale for Children (BPRS-C)

Decrease in the severity of symptoms








Hospital Diagnosis







2020:
KidsPeace Response

In 2020 the COVID-19 pandemic presented enormous challenges to KidsPeace's operations and people - but an organization with epidemic relief in its DNA was well-positioned to respond appropriately.

Highlights



Facing the threat

Early in 2020 KidsPeace's risk management team identified the COVID-19 outbreak as a potential disruptive event, and leaders activated a "pandemic plan" to assess impact on our operations. Relying on guidance from its medical leadership, the organization implemented significant mitigation efforts starting in March – mask mandates, screening and visit limitations, required use of PPE, "work-from-home" policies for administrative staff, and enhanced communication with associates on infection control efforts.

The KidsPeace pandemic plan identified the Orchard Hills Campus congregate care programs as being at particular risk, and targeted additional mitigation efforts there. Space at KidsPeace Children's Hospital was repurposed for an isolation unit for clients diagnosed with or exposed to COVID-19, and school and activity schedules were changed to prevent intermingling of clients from different residential units, further protecting against infection. (A similar approach was taken in residential programs in Georgia and Maine, and while both programs saw an increase in cases in the fall, the experience gained at Orchard Hills helped keep the incidence of infection at manageable levels.)

Stringent infection control practices also were put in place in our outpatient and community programs. In addition, KidsPeace expanded its use of telehealth to deliver treatment when clients could not attend in person. KidsPeace foster care staff also used telehealth capabilities to maintain connection with foster families; for example, several families were still able to complete their adoption process amid the pandemic using teleconferenced judicial proceedings.

Financial impact – and help from partners and supporters

COVID-19 brought a significant financial impact resulting from declining client counts, staff shortages due to quarantine and isolation, and unexpected infection-control facility costs. But federal coronavirus relief packages, along with state assistance, prevented large-scale layoffs. At the same time, payors like managed care organizations

(MCOs) worked with us on alternative payment strategies that helped ensure that our programs could continue to provide care to the populations they serve.

Our organization's ability to continue providing services was bolstered by the generosity of the community at large. An army of sewing enthusiasts delivered shipments of handmade reusable cloth face masks, and supporters provided meals for direct care staff in Georgia, Maine and Pennsylvania. Kids in Pennsylvania residential treatment received Easter baskets courtesy of a Lehigh Valley candy company, and Christmas gifts donated by members of the community. Targeted donations supported the free walk-in assessments offered at PA outpatient programs and the TeenCentral. com web based therapeutic support service - which saw its traffic soar as youth kept from school and outside activities sought out support on their own.

"Heroes Work Here'



Early in the pandemic, a manager in Georgia had a banner made to remind KidsPeace associates how much they were appreciated. The banner read: "HEROES WORK HERE" ... and within weeks banners with that same message were displayed at all KidsPeace facilities.

Direct-care staff across our programs used their creativity and commitment to overcome the barriers of infection control measures in serving the needs of clients, just as administrative staff overcame those barriers to support them – all while coping personally with the very human fear and anxiety sparked by a global health crisis. Thanks to the hard work and dedication of its associates, KidsPeace was able to withstand the most destructive aspects of the pandemic to continue to fulfill our mission.

Stockpiling MPE – Mental-health Protective Equipment

In the fall of 2020 KidsPeace's Chief Medical Officer Dr. Matthew Koval considered the long-term implications of the COVID-19 pandemic on mental wellness in our society, and recognized a change in the type of stress experienced by those coping with the pandemic.

Early in the pandemic, individuals experienced *acute stress*, which Dr. Koval likened to that experienced by residents of an area hit by a hurricane. But as the COVID-19 pandemic continued to spread, mitigation efforts did not slow its progress or eliminate its impact. In Dr. Koval's weather analogy, it was as if hurricanes hit our communities every day, and no one could say authoritatively when they would stop. The acute short-term stress of the early pandemic turned into long-term *chronic stress* - posing a different threat to mental wellbeing.

In response, Dr. Koval thought back to the need for Personal Protective Equipment, or PPE, and the failure to have enough of it on hand early in the pandemic. Going forward, he reasoned, individuals needed to learn how to stockpile mental health protections ahead of the need.

And so, KidsPeace proposed the "Mental-health Protective Equipment (or MPE) Toolkit" – a set of tools to strengthen resilience and mental wellbeing against the negative impacts of chronic pandemic stress. We launched the MPE Toolkit in November 2020, featuring a graphic presentation of its principles and suggested actions (see below).


While the MPE Toolkit was developed in response to the COVID-19 pandemic, it can serve as a template for addressing other chronic/persistent stress situations in the future.

TeenCentral.com

The HELP tab was the most visited tab on TeenCentral in 2020, showing that teens utilized the site to find help for their problems throughout the pandemic. The second most visited tab was the "Stories" tab, hopefully reducing isolation for youth who very likely were dealing with extreme loneliness during the pandemic.






Resources and Expenditures

Over its 139-year history, KidsPeace has built a reputation for providing a level of care noted for its exceptional quality and effectiveness. For a nonprofit like KidsPeace, providing such care requires substantial financial resources. The bulk of our funding comes from fees paid by governmental agencies and private insurers; we are fortunate also to have a base of generous donors - individuals, foundations and granting organizations - who provide additional funding for our variety of services.

More than four out of every five dollars spent by KidsPeace in 2020 went toward program expenses to provide care and treatment to our clients, with the remainder funding administration, marketing and advancement activities.





Definitions for statistical categories:

¹Clients Served – Total number of children and adults receiving direct services from KidsPeace in 2020.

²Clients in Programs – Number of children and adults who received direct services at least once in a specific KidsPeace program in 2020

³**Episodes of care** – Total number of instances in which care was provided to a client in a KidsPeace program in 2020

NOTE: Individuals can receive care from multiple KidsPeace programs on multiple occasions during the year. Example:

- An individual who is treated at KidsPeace Children's Hospital would be counted once in each statistical category: as a client served, a client in a specific program, and as receiving one episode of care.
- If that individual moves to a residential program, they are counted as a new client coming into that program and as receiving a second episode of care but NOT as a new client served by KidsPeace.
- If the individual then returns to the Hospital for further treatment, they are NOT counted as a new client served or a new client in the program, but their treatment IS counted as a third episode of care.
