

## **WELCOME**

Dear Friend of KidsPeace,

Welcome to the KidsPeace Annual Report for 2021 - a year that saw us continue to cope with the COVID-19 pandemic and its impact on mental and behavioral healthcare in America, and to be reminded that it's often in meeting significant challenges that an organization like ours finds opportunity for growth and renewal.

The advent of the COVID-19 vaccines at the beginning of 2021 allowed us to continue to serve children, adults and families who are facing mental and behavioral health issues, amid an unexpected effect of the pandemic: a significant reduction in the stigma surrounding mental healthcare. Parents and families saw the stress, anxiety and depression that their kids experienced as a result of pandemic-mandated isolation, and understood the need to address those problems through programs like ours.

Unfortunately, the pandemic's impact on our staffing following years of inadequate funding constrained our ability to meet that increased demand. For example, referrals into our programs hit an all-time high in 2021 - but the percentage of those referred clients that we could accept fell dramatically from previous years. Our experience illustrates challenges between demand and capacity that mental health providers will be facing for years to come.

But as I noted, challenges can be the source of an organization's renewal. Evolving our offerings to meet the changing needs of children and families is in our organization's DNA -- as is the incredible dedication and caring of our associates. Their efforts meant that despite the pandemic, we were able to provide Hope, Help and Healing to thousands of people in need last year:

- KidsPeace continued to receive high marks from its clients in post-discharge satisfaction surveys.
- Strong majorities of clients in key parts of our Continuum of Care saw their symptoms reduced or were moved to less-restrictive care as a result of our services.
- Our kids also continued to keep up with their peers in education advancement while being treated in our residential programs.
- And strong community and philanthropic support of KidsPeace continued in 2021 -- with more than 1,100 individuals and organizations contributing through the year.

As 2021 ended, we launched a celebration of two major anniversaries in 2022 - the 140th anniversary of the founding of our organization, and the 30th anniversary of our adopting the name "KidsPeace." I believe what we really are celebrating is a legacy of growth and renewal in response to challenges -- the sort of achievement we work so hard to deliver to all the people for whom we care, every day.

Thanks to all our associates, friends and supporters for their belief in our mission during the times of challenge and renewal in 2021!






## **EDUCATION**

Despite the continuing challenges faced by schools and educators from the COVID-19 pandemic in 2021, KidsPeace youth continued to receive quality education during their residential placement. Students in youth residential treatment attend on-campus classes with emphasis on the curriculum for their current grade level and home school district requirements (including Individualized Education Plan (IEP) goals). Many of the students that come to KidsPeace are three to four years behind their peer group academically.

In 2021, our goal was to maintain skill levels identified prior to the COVID-19 shutdown of schools. 75% of our PA Residential student population experienced gains in their academic performance in math and 83% of students showed academic improvement in their reading scores during their residential placement with KidsPeace, as shown in the graphs below.

Similarly, kids in our foster care operation overwhelmingly completed the school year and advanced a grade. In Maine, students performed well above average in tests measuring typical academic growth.









## **GEORGIA RESIDENTIAL**



Locations: Bowdon, GA
Clients served: 99 in 2021

**Services:** Residential care and treatment services for Georgia youth. The 80-bed facility is designated as a Maximum Watchful Oversight Program, with four 20-bed living units. Three of the units serve 20 girls and 40 boys with a range of mental health, substance abuse and behavioral challenges; the fourth unit is a separate 20-bed unit for male youth with sexual behavior challenges. An on-site school, recreational facilities, and

a wellness and behavioral-health center serve the needs of the youth in the program. The campus also offers outpatient walk-in counseling and mental health treatment programs to the community.











## BRIEF PSYCHIATRIC RATING SCALE FOR CHILDREN (BPRS-C)

Decrease in the severity of symptoms




## PENNSYLVANIA RESIDENTIAL



# A HISTORY OF GROWTH AND RENEWAL IN THE FACE OF CHALLENGES: KIDSPEACE'S 140 YEARS OF DELIVERING HOPE, HELP AND HEALING

The dramatic effects of the COVID-19 pandemic will have an impact on our lives for many years to come. Such societal upheavals prompt confusion and fear, but they also carry with them the opportunity for growth and renewal for organizations committed to serving people. In crises, new needs emerge among those cared for by human service agencies, and organizations like ours are challenged to evolve their offerings in response.

It's a dynamic in place today amid COVID-19, as it was almost a century and a half before ... when another illness presented a community with the opportunity to evolve to help those in need.

"The smallpox has broken out in good earnest in South Bethlehem, and the people of the town are greatly alarmed in consequence..."

-Bethlehem (PA) Daily News, March 13, 1882

Throughout the 1800s in the United States, the challenge of helping the less fortunate did not include governmental programs or funding. (It would not be

until the New Deal era of the 1930s that federal action to aid those in poverty would be enacted, in response to the Great Depression.)


Instead, private charities flourished - first, groups serving those sharing religious, ethnic or professional ties, and then efforts to aid residents in the newly urbanized cities of the Industrial Revolution regardless of personal affiliations - evolving to recognize that poverty and sickness did not discriminate along such lines.

It was in this environment in 1882 that a smallpox epidemic ravaged working-class neighborhoods around the operations of the Bethlehem Iron Company, led at the time by its president, William W. Thurston.

Thurston realized that of the dozens of adults who succumbed to the disease, many were workers in his plant. An orphan himself, he was moved to establish a children's shelter in South Bethlehem to care for the children orphaned by the epidemic while lasting homes were found for them. He and other community leaders later incorporated the shelter as "The Children's Home of South Bethlehem" and began to expand its care to more kids in need.

From that beginning, the organization known now as KidsPeace demonstrated again and again the ability to evolve to meet the changing needs of kids, adults and families, across six distinct eras of growth and renewal. Since Thurston's home opened in 1882, more than 300,000 individuals have

received help through KidsPeace programs.



As the pandemic is lifting its fog, we find there is a growing prevalence of burnout among our associates. The jobs are demanding and highly stressful. Life-and-death situations are part of the everyday work routine. In addition to burnout we see associates suffering compassion fatigue and in some cases, vicarious trauma.

KidsPeace recognized the risk associated with a burned out, fatigued and traumatized workforce and we did something very innovative about it that has evolved into a wide umbrella of interventions known as **Oasis Services**. Even before the pandemic the leaders of the Oasis Response Team were faced with a problem - repeated requests to provide support to staff who were experiencing symptoms of compassion fatigue and vicarious trauma. As they say, "necessity breeds invention", and so it did!

Over the course of 2 years Oasis leaders developed a continuum of Oasis Services that are available for both staff and children in care; services that include both mobile programs that move to the people who are suffering and also stationary spaces to which staff and children can visit as needed and appropriate.

Oasis for the future...

KidsPeace wants our associates to value self-care and wellness and we encourage this is many ways. Self-care is to engage in self- preservation. It's to engage in strategies that protect our own well-being and happiness. It's an intentional activity designed to care for our mental, emotional, spiritual and physical health.

A truly innovative step into the future for mental and behavioral healthcare, KidsPeace has partnered with Alliance Health in North Carolina to create a service that will eliminate the need for many families to access emergency rooms in order to access care. What a concept!

The Hope Center will offer much more than a bed for waiting when it opens its doors in 2022. From the moment a family engages with the Hope Center either through the MORES crisis team or some other way, they will see that therapeutic treatment is available from the first moment. Highly trained staff secure the 23 hour stabilization unit which contains an Oasis room and other resources to help the child return to baseline from the crisis situation. This type of strategy can help youth avoid expensive inpatient treatments when they may not really need them. And those who do need them can take advantage of the Hope Center's facility based 24/7 services.

The Alliance-KidsPeace partnership is just one blazing example of how KidsPeace intends to walk into the future creating new ways for youth and families to access mental and behavioral health care in new innovative ways that are safe, less restrictive and strengths based.



## **ASSOCIATE RECOGNITION**

The strength of KidsPeace over its long history has always been our thousands of dedicated associates – who come from all circumstances of life, and bring their experiences and life lessons to the challenge of helping those in need. No matter what program they work in, or what their specific function may be, our associates share a spirit and passion for the success of the kids and other clients in our care. ## RESOURCES AND EXPENDITURES

Over its 140-year history, KidsPeace has built a reputation for providing a level of care noted for its exceptional quality and effectiveness. For a nonprofit like KidsPeace, providing such care requires substantial financial resources. The bulk of our funding comes from fees paid by governmental agencies and private insurers; we are fortunate also to have a base of generous donors - individuals, foundations and granting organizations - who provide additional funding for our variety of services.

More than four out of every five dollars spent by KidsPeace in 2021 went toward program expenses to provide care and treatment to our clients, with the remainder funding administration, marketing and advancement activities.
