Progress in Addressing Sexual Abuse

The Prison Rape Elimination Act (PREA) of 2003, 42 U.S.C. 15601 et Seq., regulations that adopt national standards for the detection, prevention, reduction and punishment of prison rape. The finalized PREA standards were released on August 20, 2012, with an implementation date of August 2013. **Pursuant to 115.88 of the Prison Rape**

**Elimination Act, KidsPeace National Centers of Georgia is required to:**

- (a) Review data collected and aggregated in order to assess and improve the effectiveness of its sexual abuse prevention, detection and response policies, practices and trainings including by:
  - (1) Identifying problem areas;
  - (2) Taking corrective action on an ongoing basis; and
  - (3) Preparing an annual report of findings and corrective actions for KidsPeace National Centers of Georgia.
- (b) Such report shall include a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the agency's progress in addressing sexual abuse.
- (c) KidsPeace National Centers of Georgia reports shall be approved by the agency head and made readily available to the public through its website or, if it does not have one, through other means.
- (d) KidsPeace National Centers of Georgia may redact specific materials from the reports when publication would present a clear and specific threat to the safety and security of a facility, but must indicate the nature of the materials redacted.

**Data Collection:**

During the calendar year from July 1, 2021 through June 30 2022, KidsPeace National Centers of Georgia collected the referrals for investigation into allegations in order to report findings to the Department of Juvenile Justice for their annual Survey of Sexual Violence. The data received is the basis for this section of the report.

**Client to Client Sexual Abuse**

KidsPeace National Centers of Georgia defines sexual abuse of a client by another client as any of the following acts:

- (1) Contact between the penis and vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and the penis, vulva or anus;



- (3) Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object or other instrument;
- (4) Any other intentional touching, either directly or through the clothing of the genitalia, anus, groin, breast, inner thigh or the buttocks of another person, excluding contact incidental to a physical altercation.

From July 2021 through June 2022, KidsPeace National Centers of Georgia, had two (2) substantiated incidents of **Client to Client Sexual Abuse**.

1. A Client to Client Sexual Abuse incident occurred on 11/25/2021 as determined by the Department of Juvenile Justice, when KidsPeace staff reported that when he checked the multipurpose room, 1 Department of Juvenile Justice youth and 1 Department of Family and Children services youth were observed engaging in oral sex. The 2 youth admitted that they had performed oral sex on one another.
2. A Client to Client Sexual Abuse incident occurred on 05/29/2022, as determined by the Department of Juvenile Justice, when a Department of Juvenile Justice youth and Department of Family and Children Services youth engaged in a sexual act (intentionally touched penis) while on the unit.

#### **Client to Client Sexual Harassment**

PREA defines Youth-on-Youth Sexual Harassment as repeated unwelcomed sexual advances, request for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one youth directed toward another youth. From July 2021 through June 2022, KidsPeace National Centers of Georgia, received zero (0) substantiated incidents of **Client on Client Sexual Harassment**.

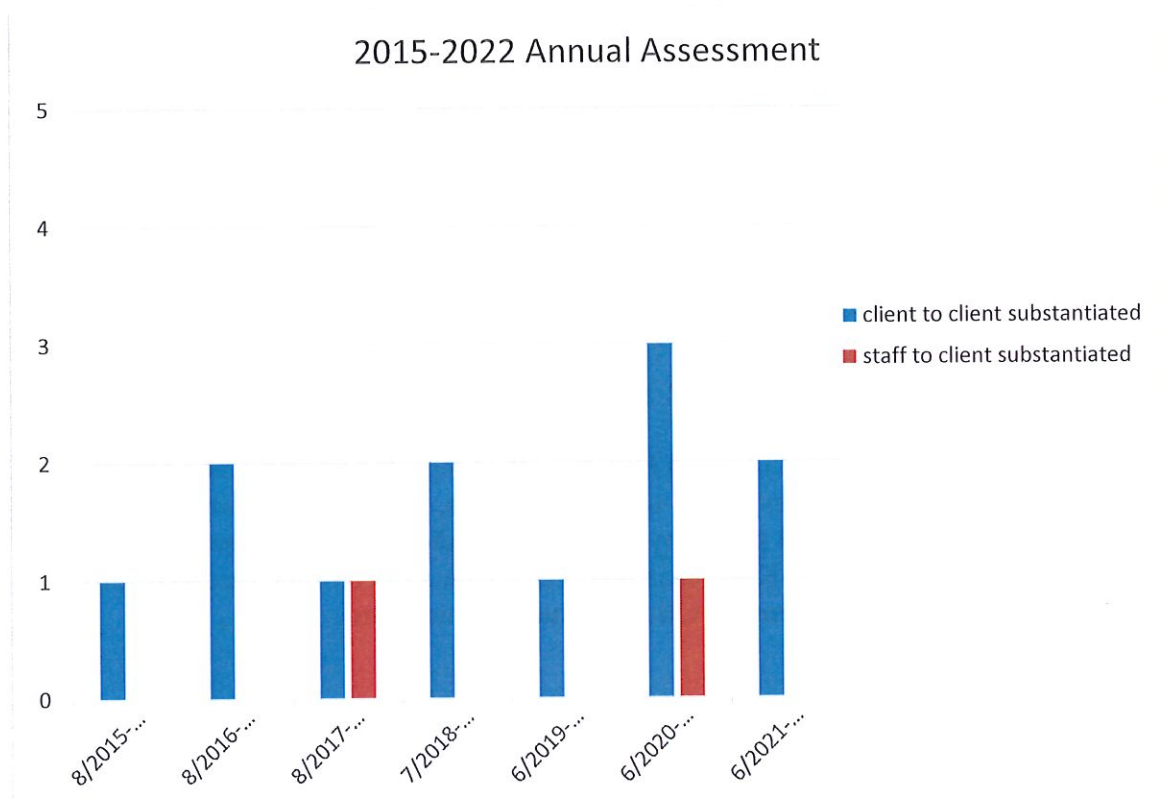
#### **Associate to Client Sexual Abuse**

KidsPeace National Centers of Georgia defines sexual abuse of a client by an associate/volunteer as any of the following acts:

- (1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and penis, vulva or anus;
- (3) Contact between the mouth and any body part where the associate, vendor, or volunteer has the intent to abuse, arouse or gratify sexual desire.
- (4) Penetration of the anal or genital opening, however slight, by a hand, finger, object or other instrument that is unrelated to official duties or where the associate, vendor, volunteer has the intent to abuse, arouse or gratify sexual desire;
- (5) Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh or the buttocks that is unrelated to

- official duties or where the associate, vendor or volunteer has the intent to abuse, arouse or gratify sexual desire;
- (6) Any attempt, threat or request by an associate, vendor or volunteer of his or her uncovered genitalia, buttocks or breast in the presence of a client, and
  - (7) Voyeurism by an associate, vendor or volunteer.

From July 2021 through June 2022, KidsPeace National Centers of Georgia had zero (0) substantiated allegation for Associate to Client Sexual Abuse.



#### **Analysis/Corrective Action:**

The current data analysis from July 2021 through June 2022 reflects a decrease in the number of sexual incidents that were substantiated during the previous (2020-2021) reporting period. A Corrective Action Plan completed by KidsPeace was submitted to and approved by the Department of Juvenile Justice following the November 25, 2021 and the May 29, 2022 incidents of Client-to-Client Sexual Abuse.

#### **The 11/25/2022 substantiated Client to Client Sexual Abuse**

##### **Analysis:**



Child Care workers shall be available to provide a staff to child ratio of 1:5 (staff to child ratio is subject to change when the safety is in question) during the day and night. Contractor shall provide 24 hour, 365 day supervision of all DJJ placed Youth.

**Corrective Action:**

Children will not be left in any room unsupervised for extended timeframes. KidsPeace ensures appropriate supervision of all children in our care through the established precaution levels and client observation policy. In order to ensure that children remain safe will in the milieu and in their rooms, all children are to be checked a minimum of every 15 minutes and these checks are to be documented. Campus Supervisors have been given instruction to provide additional oversight during rounds on the units. Ongoing education is being provided to staff via mentoring by the Unit Supervision in the milieu.

To further ensure the 15 minute checks are being completed, the Quality Assurance/Compliance Manager and the Assistant Program Director will include the checking of the 15 minute documentation in the Program Integrity Audits. If staff are found to be non-compliant with the 15 minute checks, staff are immediately addressed to rectify the situation. Continued non-compliance by any staff with completing the required 15 minute checks will result in further disciplinary action.

Staff member will attend Milieu Management training during the upcoming New Associate Orientation in order to relearn proper client observation and relation documentation.

**The 05/29/2022 substantiated Client to Client Sexual Abuse**

**Analysis:**

The Georgia Department of Juvenile Justice strictly prohibits any form of sexual activities involving youth with other youth and youth with staff, visitors, contractors, volunteers and interns as defined by the Department of Juvenile Justice PREA Standards, Georgia State Law, and Georgia Department of Juvenile Justice Policies. Child Care workers shall be available to provide a staff to child ratio of 1:5 (staff to child ratio is subject to change when the safety is in question) during the day and night. Contractor shall provide 24 hour, 365 day supervision of all DJJ placed youth.

**Corrective Action:**

Staff member will attend Milieu Management training during the upcoming New Associate Orientation in order to relearn proper client observation and relation documentation.

Client seating arrangement/positioning as it relates to social distancing, as well as, staff's ability to have full visual field of clients in timeout room will be discussed and reinforced in Unit Team Meetings.

Children will not be left in any room unsupervised for extended timeframes. KidsPeace ensures appropriate supervision of all children in our care through the established precaution levels and client observation policy. In order to ensure that children remain safe will in the milieu and in their rooms, all children are to be checked a


minimum of every 15 minutes and these checks are to be documented. Campus Supervisors have been given instruction to provide additional oversight during rounds on the units. Ongoing education is being provided to staff via mentoring by the Unit Supervision in the milieu.

**Summary:**



It's the hope of KidsPeace National Centers of Georgia that by demonstrating our belief in practicing a zero tolerance policy for sexual abuse, sexual misconduct and/or sexual harassment in our facility, that we will continue to work toward and achieve a zero account of sexual incidents in our facility
